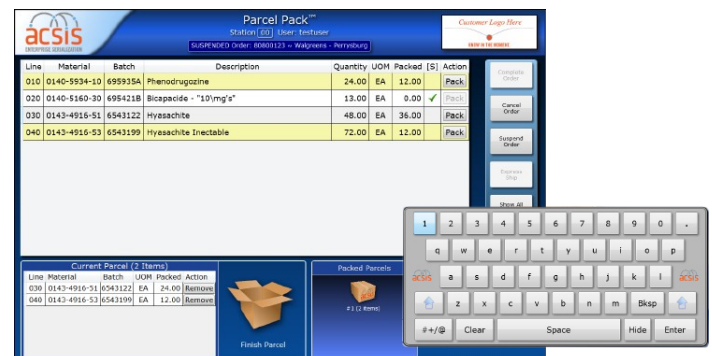

## Key Process Steps

- Operator enters order number through barcode scan or key entry.
- Operator scans items, bundle or case labels.
- Acsis Serialized Shipping Station verifies the items and updates totals of items that have been processed.
- Operator completes order and the Acsis station generates required shipping labels and manifests for each completed parcel or pallet.
- The Acsis station updates the ERP system with all relevant data related to the completed order and the EPCIS system with all serialization data.
- The Acsis station then sends e-mail notifications to customers and sales team when an order has been shipped, along with the related tracking numbers.
- Users can print or reprint shipping manifests, bills of lading, and parcel labels – even after the order has been completed.

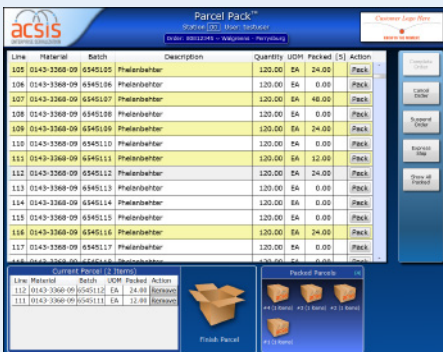

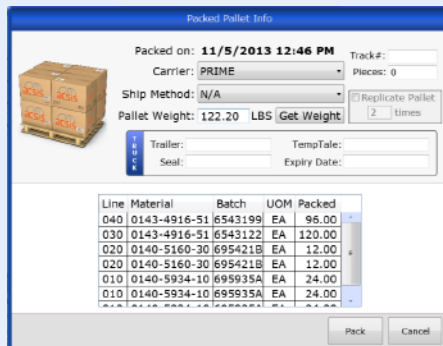

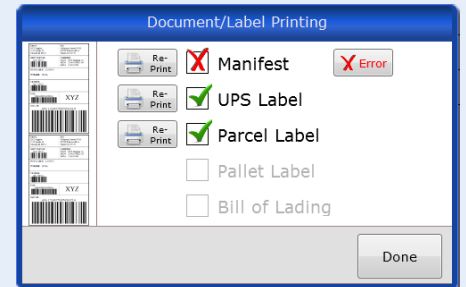
### Order Processing
